Dear Collier County Employee,

It is time for you to qualify for the Invest in Your Health program for 2024. Blood work MUST be completed by March 31<sup>st</sup>, 2023. There will be NO exceptions. Starting October 21<sup>st</sup>, 2022, you are highly encouraged to schedule your blood draw. **Registration for on-site blood draw events closes 1 week in advance. Register today!**

Who needs to Qualify to earn Select or Premium Cost Share during 2022?

1. Enrolled employees who wish to upgrade their Cost Share. (Please call Health Advocate office for information at (239) 252-5588).
2. Newly hired employees and their covered spouses.
3. Spouses new to plan who did not complete qualifiers in the past qualifying period.



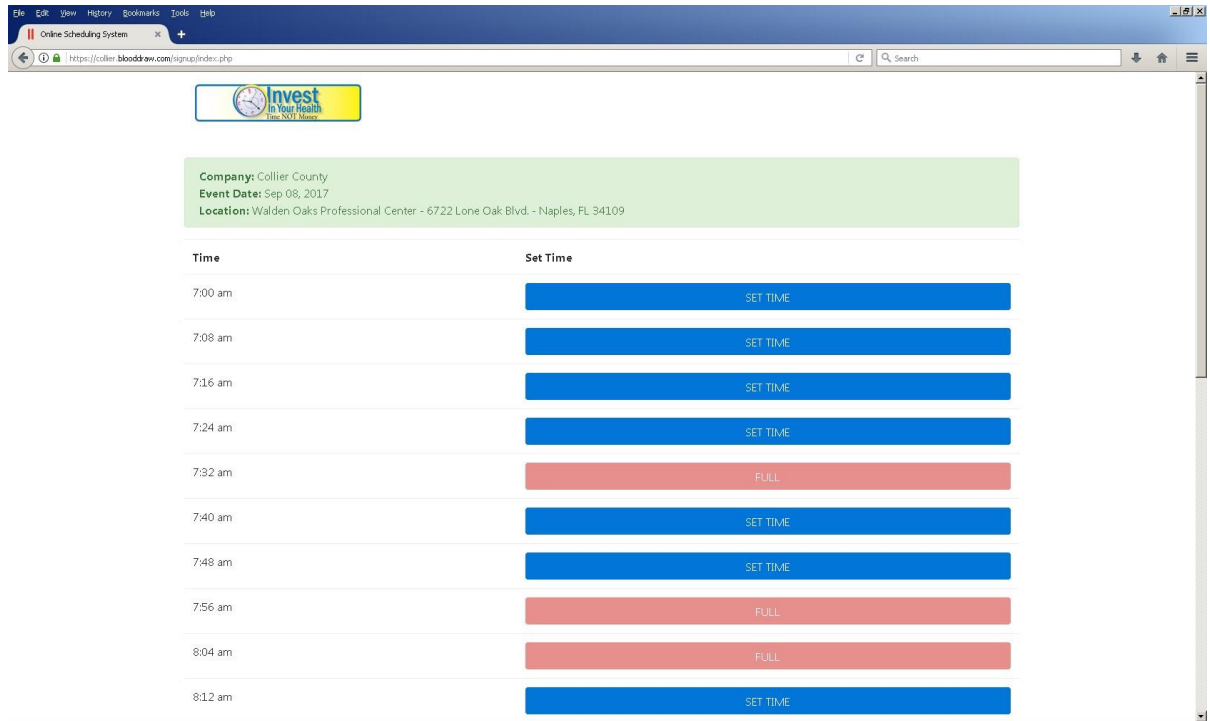

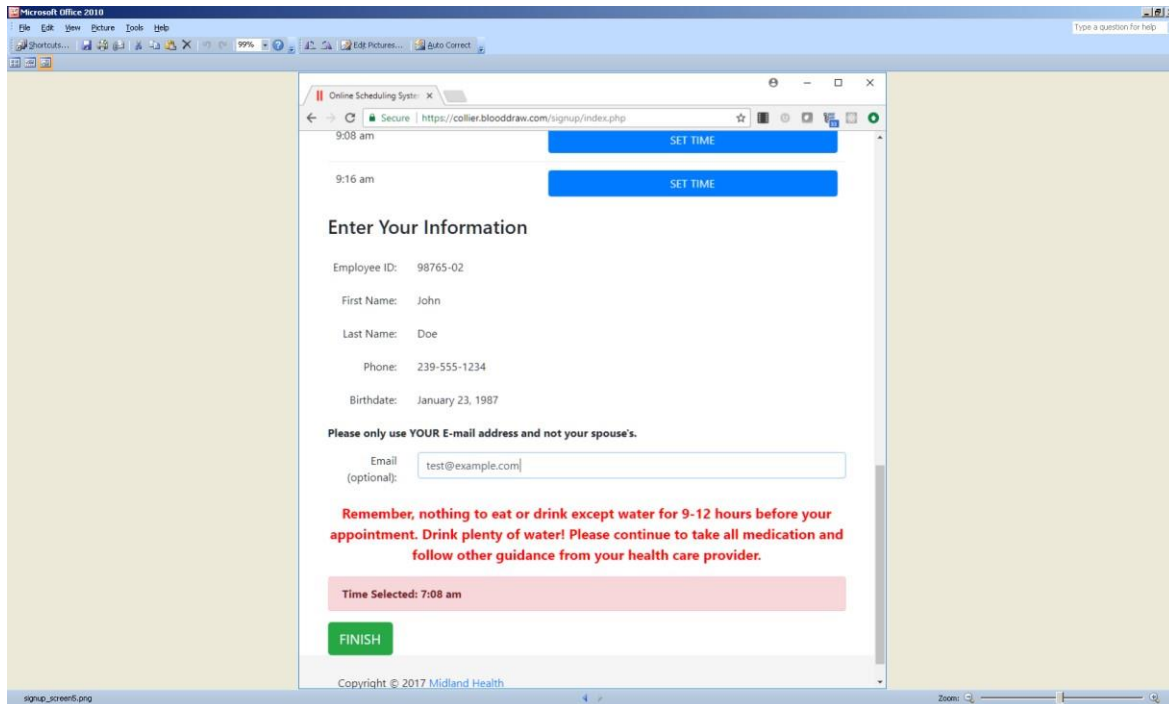

- Now click "START SIGNUP" button next to your preferred date and location to schedule your screening



- Choose a blood draw time and click "OK" to confirm



- Please enter a personal email address to receive your screening results.
- Now click "FINISH" to confirm your scheduled screening

The screening consists of a fasting blood draw and the measurement of your height, weight, waist, and blood pressure by qualified medical professionals.

**Do not eat food or drink liquids except water** for a period of 9-12 hours before your blood draw unless otherwise advised by your physician.

Drink plenty of water to remain well hydrated.

Take your medication according to your regular schedule.

- Please schedule your Health Advocate appointment today. Choose a date 3-4 weeks after your blood draw.
- Your Health Advocate will present you with your lab results. During your Health Advocate appointment.

\*REMINDER: The deadline for the Initial Health Advocate or Wellness Meeting is June 30<sup>th</sup>, 2023.
